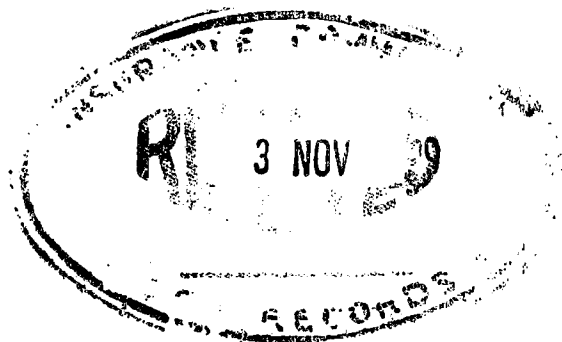
CIRCULAR LETTER
