**SUBJECT**: Alternative Work Arrangements at the Insurance Commission

(IC) Head Office, Manila during the Enhanced Community

Quarantine (ECQ) on 06 to 20 August 2021

Relative to the announcement of the Presidential Spokesperson placing the National Capital Region under Enhanced Community Quarantine (ECQ) effective 06 August 2021 until 20 August 2021, please be advised the Insurance Commission (IC) Head Office in Manila shall still observe work from home and skeleton workforce arrangement schemes.

As instructed by the Insurance Commissioner, and in accordance with the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as amended, and Civil Service Commission (CSC) Memorandum Circular No. 10, series of 2020, the following unit/division rendering frontline services shall designate one (1) Officer of the Day as skeleton workforce for the period 06 to 20 August 2021:

- 1. Public Assistance and Mediation Division
- 2. Conservatorship Receivership and Liquidation Division
- 3. Licensing Division
- 4. Administrative Division Cashier Section
- 5. Administrative Division Records Section
- 6. Life/MBAs/Trust Division
- 7. Non-Life Division
- 8. Health Maintenance Organizations (HMO) Division
- 9. Pre-Need Division
- 10. Suretyship Unit
