## INVITATION TO BID FOR SUPPLY AND DELIVERY OF VITAMIN SUPPLEMENTS FOR CY 2017

(P.R. No. 2017-04-162)

(Lot 2)

1. The Insurance Commission, through the Special Account in the General Fund 151 for the Year 2017, intends to apply the sum corresponding to the following project/Lot being the Approved Budget for the Contract (ABC) to payments under the contract for project/Lot:

Bids received in excess of the ABC for the lot shall be automatically rejected at bid opening.

- 2. The *Insurance Commission* now invites bids for the abovementioned lot on the Supply and Delivery of Vitamin Supplements for CY 2017. Delivery of the Goods is required as specified in the Schedule of Delivery. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from the Insurance Commission Bids and Awards Committee and inspect the Bidding Documents at the address given below during office hours, 9:00 AM to 5:00 PM, Monday to Friday, except holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders beginning 14 July 2017 from the address below and upon payment of the corresponding non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount, as follows:

- Bids must be duly received by the BAC Secretariat at the address below on or before <u>03</u> <u>August 2017, 1:30 PM</u>. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on <u>03</u> <u>August 2017, 2:00 PM</u> at Function Room, Insurance Commission Building, 1071 U.N. Ave., Ermita, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Insurance Commission reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA No. 9184 and its 2016 Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
