SUBJECT: Regular Holiday on 20 July 2021 (Eid'l Adha)

Pursuant to Proclamation No. 1189, issued by the Office of the President (OP) declaring *Tuesday, 20 July 2021*, as a *Regular Holiday (Eid'l Adha – Feast of Sacrifice) throughout the country*, please be advised that work at the Insurance Commission (IC) Head Office, and Cebu and Davao District Offices shall be suspended on said date.

Normal operations under skeleton workforce shall resume on Wednesday, 21 July 2021.

Those who have already confirmed their appointments with the Insurance Commission Appointment Reservation System (ICare) through https://web.insurance.gov.ph/icare/login, but are affected by said work suspension, are advised to request another schedule.

PROCLAMATION NO. 1189

DECLARING TUESDAY, 20 JULY 2021, A REGULAR HOLIDAY THROUGHOUT THE COUNTRY, IN OBSERVANCE OF *EID'L ADHA* (FEAST OF SACRIFICE)

WHEREAS, *Eid'l Adha* or Feast of Sacrifice is one of the two greatest feasts of Islam:

WHEREAS, Republic Act No. 9849 provides that *Eid'l Adha* shall be observed as a regular holiday;

WHEREAS, the National Commission on Muslim Filipinos has recommended that 20 July 2021, Tuesday, be declared a national holiday, in observance of *Eid'l Adha*: and

WHEREAS, the observance of *Eid'l Adha* shall be subject to existing community quarantine and social distancing measures;

NOW, THEREFORE, I, RODRIGO ROA DUTERTE, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Tuesday, 20 July 2021, a regular holiday throughout the country, in observance of *Eid'l Adha*.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
